RESTRICTIONS OF ROAD TRAFFIC

I.

It is prohibited to drive trucks with or without a trailer with a maximum permissible weight exceeding 7.5 tons, vehicles alone or with trailers longer than 14 m (hereinafter: trucks), tractors, carriages, work vehicles and other machinery. and vehicles that cannot move at a speed higher than 40 km / h on a flat road and vehicles for training candidates for drivers (when training in the subject of driving a vehicle), at the state ferry ports of Split and Zadar and on the following state roads:

1. on the part of the state road D8, on the route: intersection with D40 (Bakar junction) - Zadar - Split - border crossing (hereinafter: GP) Klek - (BiH border) - GP Zaton Doli (BiH border) - Dubrovnik - GP Karasovići (border of Serbia and Montenegro), except in the part from the intersection of the state road D27 (near Šibenik bridge) to the eastern entrance to Šibenik (branch for D58), and from the rotor Bilica in Solin to the intersection for turning into Trade and Transport Terminal in Stobreč ,,
2. on the state road D9, on the route: Metković - Opuzen - D8,
3. on the part of the state road D21, on the route: GP Kaštel (border of the Republic of Slovenia) - Buje - junction Kanfanar, except on the section of the state road D21 from the junction Kanfanar - to Pula (junction with D66),
4. on the part of the state road D23, on the route: Žuta Lokva - Senj,
5. on the state road D39, the connection of the A1 motorway from the Šestanovac rotor to the intersection with the state road D8 (Dupci),
6. on the part of the state road D66 from the junction Pula (A9) - Raša - Opatija - D8,
7. on the state road D200, on the route: Buje (D21) - GP Plovanija (border of the Republic of Slovenia),
8. on the state road D300, Buje (D21) - Umag,
9. on the part of the county road Ž5002 on the route: Novigrad - Tar - Poreč - Vrsar (connection with D21),
10. on the approach and areas of the state ferry port Split,
11. on the approach and areas of the state ferry port Zadar.

II.

The prohibition from item I of this Order is valid:

- from 15 June to 15 September, on Saturdays from 04:00 to 14:00 and on Sundays from 12:00 to 23:00
- on Good Friday and the days before the holidays of the Republic of Croatia from 15.00 to 23.00, on the last day of the holiday from 14.00 to 23.00.

If the holiday, ie the last day of the holiday, is Friday or Saturday, the ban is valid on Sundays from 12:00 to 23:00.

If the holiday is on a Sunday or Monday, the ban applies on the Friday before the holiday from 3pm to 11pm.

During the ban, vehicles registered in the Republic of Croatia to which this Order applies are allowed to enter the Republic of Croatia through the GP referred to in point I of this Order, and move to the nearest customs office or customs terminal, provided that there is a parking space.

III.

On Sundays, from 6.00 to 22.00, the traffic of trucks with or without a trailer weighing more than 7.5 tons on the state road D2 from Varaždin to GP Dubrava Križovljanska is prohibited.

The prohibition referred to in paragraph 1 of this item shall not apply to vehicles of legal and natural persons with their registered office or residence in the zone of the state road D2 between Varaždin and Dubrava Križovljanska and to vehicles referred to in item IV. subparagraphs 6, 7 and 8 of this Order, when they perform delivery for the needs of supply on the section of the state road D2 between Varaždin and Dubrava Križovljanska.

Hrvatske ceste doo is obliged to prohibit from point I, paragraph 1 and point III. paragraphs 1 and 2 of this Order shall be marked with appropriate traffic signs and the public shall be informed through the media.

IV.

The following vehicles are exempted from the prohibitions prescribed by this Order:

- vehicles with priority of passing and escorted vehicles,
- vehicles of the Ministry of the Interior and the Armed Forces,
- vehicles for road maintenance, electric power and similar installations and vehicles for delivery of mail and press,
- radio and television reportage vehicles,
- tanks carrying drinking water,
- vehicles transporting materials or equipment essential in an emergency,

- lorries or lorries with semi-trailers intended for the transport of concrete, asphalt and motor fuels for motor vehicles, except on the state road D2, between Varaždin and Dubrava Križovljanska, on which they can operate under the conditions prescribed in point III. of this Order,

- lorries or lorries with semi-trailers transporting perishable foodstuffs, such as: fresh meat and fresh meat products, fresh milk and milk products, fresh fish and fish products, perishable fruit and vegetables, except on state road D2, between Varaždin and Dubrava Križovljanska, where they can operate under the conditions prescribed by point III. of this Order,

- lorries or lorries with semi-trailers transporting livestock and poultry, except on the state road D2, between Varaždin and Dubrava Križovljanska, on which they may operate under the conditions prescribed in point III. of this Order,

- other licensed vehicles, only where, in view of the time and circumstances, the transport is particularly justified or strictly necessary for safety reasons, or because its delay would cause major material damage.
